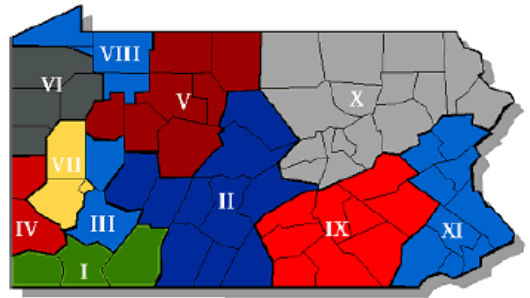


PENNSYLVANIA JUNIOR WRESTLING

On behalf of the Pennsylvania Junior Wrestling Area XI committee we would like to invite you to what we hope will be the best wrestling experience you have this year. This years Pennsylvania Junior Wrestling State Championship once again will include four sectional tournaments. The top three wrestlers from each Sectional Qualifier will advance to the Area XI Championship to be held at LaSalle College High School on March 20th and 21st 2010.

Our goal is to bring the quality and professionalism of the Pennsylvania Junior Wrestling to the local qualifiers so that everyone can enjoy the PJW experience. Each of the sectional qualifiers is a double elimination tournament designed to provide each participant with the best experience possible and ample opportunity to advance to the Area XI Championship.

The Area XI committee is making every effort to assure that the Championship series is the gold standard in youth wrestling. To provide the most opportunity for kids the top three finishers in each of the 8 & under, 9-10, 11-12 and 13-14 divisions will advance to the Area XI Championship. We have set up the Area XI Championship as a two day event to assure that it is a great day for our participants and to make sure it does not turn into a marathon that tests their patience and their endurance and not their skill.

Pennsylvania has a proud tradition of producing some of the premier wrestlers in the nation. Last year we had 61 medal winners and 12 Champions from Area XI. We hope to honor that tradition and have even a bigger year at states this year.

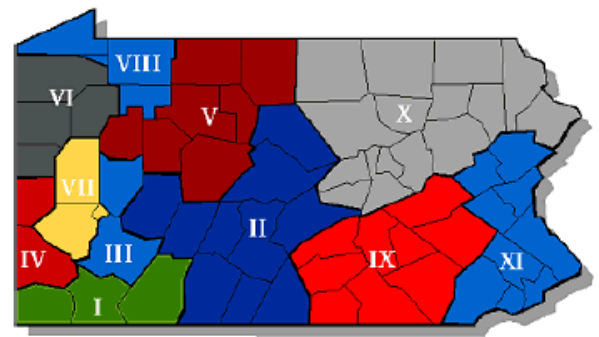

AGE EFFECTIVE DATE: December 31, 2009 (see rule #3 on page 3)

ELIGIBILITY: Only full-time residents of Bucks, Carbon, Chester, Delaware, Lehigh, Monroe, Montgomery, Northampton, and Philadelphia Counties as well as Berks County residents who reside within the boundaries of the Upper Perkiomen School District or Boyertown School District may enter the Area XI the Sectional Tournaments. Sections are open so wrestlers can enter more than one section but may only qualify from one. Any wrestler who places top three in more than one sectional qualifier will be disqualified from the PJW Area XI Championships.

AWARDS: Awards for the top three finishers in each weight class.

FORMAT: Double elimination (no true second).

AREA XI CHAMPIONSHIPS: The top three place winners* in the Sectional Qualifiers advance to the PJW Area XI Championships at LaSalle College High School March 20th and 21st 2010. No Advancement fee but qualified wrestlers will need to fill out the advancement form and sign the participation waiver. Area XI Championship to be seeded by formula from results of sectional qualifiers. (*6 & Under does not advance)

STATE CHAMPIONSHIPS: The top two place winners in the Area 11 Championship (all weights in 8 & under, 9-10, 11-12 and 13-14) advance to the State Championships at the Wachovia Arena in Wilkes-Barre, Pa. March 20th and 21st, 2010.

RULES AND REGULATIONS

1. The top three finishers in all weights in the 8 & Under, 9-10, 11-12 and 13-14 advance to the Pennsylvania Junior Wrestling Area XI Championship at LaSalle College High School on March 20th and 21st, 2010. (6 and under division does not advance to the Area XI Championship) Additional fees may apply.
2. The top two finishers in all weights in the 8 & under, 9-10, 11-12 and 13-14 from the Area XI Championship are eligible to advance to the Pennsylvania Junior Wrestling State Championship March 26th and 27th, 2010.
3. A wrestler's age group classification is determined by his/her age on December 31, 2009.
EXAMPLE: A wrestler's 11th birthday is 1/1/2010. That wrestler competes in the 10 and under division.
4. Participants may enter one sectional tournament, one weight class and one division only. 6& Under may compete in either 6&Under or 8&Under but not both. No Double Bracketing.
5. Each weight class in each age division will include all wrestlers whose weight is less than or equal to the labeled weight of the weight class. There is no weight allowance at the Sectional or Area XI Championship.
6. A wrestler cannot wrestle outside his/her age group, unless he/she weighs more than the heaviest weight class in his/her age group.
7. National Federation and PIAA rules will govern all matches except as follows:
All 6 & Under bouts will consist of three periods of 1 - 1 - 1.
All 8 & Under, 9-10, 11-12 and 13-14 bouts in the championship bracket will consist of three periods of 2 - 1 - 1.
All Consolation matches will consist of three periods of 1-1-1.
Overtime to be 1 minute sudden death followed by one (1) 30 second ride out period.
8. PLEASE NOTE THAT HEADGEAR IS REQUIRED IN ALL PJW TOURNAMENTS.
9. Mouth Guards are required for participants with braces.
10. AGE CHALLENGE RULE - Challenger and Challenged must provide proof of age. Bring your Birth certificate with you.) Birth certificates or copies of birth certificates will be required of all finalists at the Area XI Tournament and for all wrestlers competing in the PJW State Championship Tournament.
11. The source of rules governing this tournament will be:
 - a. The P.I.A.A. Rule Book
 - b. The Pennsylvania Junior Wrestling Rules Booklet
 - c. The Area Rules that apply to the operation of each qualifying tournament.
12. The hair rule for the Pennsylvania Junior Wrestling tournaments will be enforced as defined in the National Federation Rules Book and adopted by the P.I.A.A.
13. Shoe laces must be secured per National Federation and PIAA rules.
14. Only fulltime residents of Pennsylvania may enter the Pennsylvania Junior Wrestling tournaments.
15. Counties eligible in Area XI are: BUCKS, CARBON, CHESTER, DELAWARE, LEHIGH, MONROE, MONTGOMERY NORTHAMPTON & PHILADELPHIA. Berks County residents of the Upper Perkiomen and Boyertown School Districts may also enter the Area 11 Tournament. Competitors deemed to be ineligible after registration shall be removed without refund.
16. Submitted entry form must include weight class and age division. Forms with out age/weight class will be returned and the wrestler will not be registered in the tournament until completed form is received.
